APPLICATION FOR GRANT AID - NON-TURF PITCHES / BATTING ENDS / NETS

SECTION ONE - CONDITIONS (PLEASE READ CAREFULLY BEFORE COMPLETING THE APPLICATION)

1. Applications will be considered from cricket clubs affiliated to a National Governing Body of Cricket, individual schools or other organisations directly involved in the organisation of youth cricket and which have a **genuine need for assistance**.
2. Applications **will not** be accepted from clubs or schools involved in the Chance to shine programme.
3. **All** Applications must be countersigned by the appropriate County Cricket Board (CCB) or Lord's Taverners Regional Chairman **prior to submission**. Contact details can be found at www.lordstaverners.org or by ringing Janine Holt on 0161 877 6643.
4. Applicants must only use the ECB Approved Non-Turf Pitch Systems & Suppliers (see Section Five) for projects involving Non-Turf Pitches / Batting Ends. This does not apply to Nets / Netting Systems.
5. A copy of an official quotation from the chosen Supplier(s) must be submitted at the time of application.
6. Applicants must **await formal written approval** from The Lord's Taverners **prior to the work being undertaken**. Consideration **will not** be given to an application where work on the project has already commenced.
7. Any changes to the project specification or choice of Supplier after an award has been granted must be notified to The Lord's Taverners immediately as this may affect the award amount. Failure to do so may result in the revised project being ineligible and the award being reduced or removed in entirety.
8. All projects must be completed within **9 months** of receiving formal written approval.
9. Grant Aid awards will only be paid upon completion of the project and upon submission of a copy of the final invoice(s) to The Lord's Taverners.
10. The Lord's Taverners reserves the right to reduce the amount of award where the final expenditure is less than the quotation on which the award is based.
11. Successful applicants must insure their Non-Turf Pitch / Batting Ends / Nets on completion of installation.
12. Successful applicants must undertake to maintain the Non-Turf Pitch / Batting Ends / Nets (as per the Supplier's specification).
13. Successful applicants may be required to cooperate in a cheque presentation or official opening of the facility to derive maximum publicity to promote the fundraising activities of The Lord's Taverners.
14. Successful applicants are not eligible to re-apply for funding within two years of receiving an award.
15. Please be aware that the majority of projects that include the erection of a permanent net facility will require planning permission. Applicants should confirm with their local Planning Office at the earliest opportunity.
16. In the event of a successful applicant disbanding within five years of the grant aid payment, The Lord's Taverners must be informed immediately and reserves the right to re-claim a proportion of the award.
